We are pleased to see the new Fulbright-MoRST Graduate Awards coming into fruition with 12 grants to present in this first year. # Fulbright-Platinum Triangle Scholarship in Entrepreneurship

This highly prestigious and competitive scholarship is for a talented New Zealander in a knowledge economy-related field to study towards a Master's degree at an American university and to gain professional work experience in both the US and New Zealand. The scholarship has the following entitlements:

- return airfare to the US
- cost of university attendance support (fees and living costs) up to US\$100,000
- a paid internship of up to nine months duration
- access to employment or sweat equity venture capital contacts upon return to New Zealand
- basic health and accident insurance up to US\$50,000
- support and enrichment seminars run by the Institute of International Education (IIE) throughout the grantee's stay in the US

# Fulbright-EQC Graduate Award in Natural Disaster Research

This award, created in partnership with the Earthquake Commission, is for a promising graduate student to undertake postgraduate study or research at a US university in the area of natural disaster research, which, for the purposes of this award, is defined as “research into the risks posed by natural disasters, the hazards they present, their impact, society's vulnerability, mitigation and management measures.” The award has the following entitlements:

- return airfare to the US
- a one-off payment of up to US\$25,000
- basic health and accident insurance up to US\$50,000
- support and enrichment seminars run by IIE throughout the grantee's stay in the US





## Privahini Bradoo

Privahini Bradoo from Auckland is the second recipient of the prestigious Fulbright-Platinum Triangle Scholarship in Entrepreneurship. Privahini will complete a Master of Business Administration degree at the Harvard Business School in Boston.

Born in India, Privahini has lived and studied in New Zealand since 1998. She graduated from the University of Auckland with a Bachelor of Technology with First Class Honours (majoring in Biomedical Science) in 2002. She received a Foundation for Science, Research and Technology Bright Futures Enterprise Fellowship to complete a PhD (majoring in Neuroscience) at the University of Auckland's Liggins Institute. While studying, she served as the inaugural CEO of Spark\* - the University of Auckland Entrepreneurship Challenge - and received a School of Business Dean's Award for outstanding leadership and innovation in 2004. She also founded Chiasma, an initiative aiming to encourage the spirit of enterprise amongst the university's biotech community.

Privahini looks forward to the experience and challenge of Harvard Business School, and her dream is to establish an innovative New Zealand biotech enterprise, ensuring that Kiwi ingenuity and excellence are taken to the world.



## Clinton Mexted-Freeman

Clinton Mexted-Freeman from Porirua is this year's recipient of the Fulbright-EQC Graduate Award in Natural Disaster Research.

Clinton will complete a Master of Science degree, specialising in crisis, emergency and risk management, at the George Washington University in Washington, DC.

Clinton graduated from Victoria University of Wellington with a Bachelor of Commerce (majoring in Economics and eCommerce) in 2004 and a Bachelor of Science (majoring in Geophysics and Maths) in 2005. He received an Australian National University Honours Scholarship and Australian Institute of Geoscientists Honours Bursary to complete his Honours in Physics of the Earth (majoring in Seismology) at the Australian National University in Canberra in 2005.

Clinton plans to specialise his research in earthquake hazards, taking a multi-disciplinary approach to advance knowledge in the use of fault locations and earthquake magnitude for examining the dangers posed to both people and infrastructure. To this end, he will examine areas of both government legislation and engineering principles. Upon returning to New Zealand he hopes to apply his knowledge either within the building and construction industry or through local and central government.

# Fulbright-Ministry of Research, Science and Technology Graduate Awards

These awards are for promising graduate students to undertake postgraduate study or research at a US institution in areas targeted to support growth and innovation in New Zealand. Broadly, this includes enabling technologies such as biotechnology and Information Communication Technology (ICT), emerging areas of science such as nanotechnology, and areas of study relevant to New Zealand's sustainable economic development and future economic growth. This includes, but is not limited to, research on food, agriculture, niche manufacturing, creative technologies, energy and environmental sciences.

The awards have the following entitlements:

- return airfare to the US
- a one-off payment of up to US\$25,000
- basic health and accident insurance up to US\$50,000
- support and enrichment seminars run by IIE throughout the grantee's stay in the US

This year, the inaugural year of Fulbright-Ministry of Research, Science and Technology Graduate Awards, 12 awards are being presented.

- basic health and accident insurance up to US\$50,000
- establishment and research allowance of NZ\$1,000
- baggage, project and incidental allowance of NZ\$1,000
- support and enrichment programmes run by Fulbright New Zealand throughout the grantee's stay in New Zealand

This year 9 awards were presented.
