Official Information Act request: Staffing

Your request under the Official Information Act 1982 to the Chief Executive dated 24 August 2007, has been referred to me for a response. I have addressed each of your queries in the numerical order in which they were asked

1. The number of investigations of employees undertaken in each of the previous five financial years were:

5. The Department does not maintain a database of appointment reviews in a way that would enable your question to be answered. The Department

- The Department does not maintain a data base detailing if an employee is related to an other employee. Your request is therefore declined under Sections 18 (e) and (f) of the Official Information Act 1982.
- Based on information held in the Department's payroll system 91 employees were acting in Management positions as at 14 September 2007.
- 11. The Chief Financial Officer resigned from the Department with effect from 18 May 2007. He received no payout.
- 12. Actors are used occasionally to role-play specific scenarios for a work based example as part of the selection process for Senior Corrections Officers and Principal Corrections Officers. Since 2004 the total cost of this service is \$7910.
- 13. The Department does not maintain a data base that collects the information requested. To do so would require a search of all staff and management individual contracts. Your request is therefore declined under Sections 18 (e) and (f) of the Official Information Act 1982.
