Dear Simon

You asked a question for written answer which was unable to be answered within the normal written question timeframe. This question required a substantial amount of data to be extracted from the Ministry of Justice's Case Management System, which is why this response has taken longer than anticipated.

QWA 09325 (2007) - How many criminal files have not progressed to trial because defendants have absconded on bail or failed to appear, specified by district court where the files are held?

All information provided in this response is derived from data stored in the Ministry of Justice's Case Management System (CMS). CMS is the first comprehensive national database for criminal cases. It has been fully operational in all criminal jurisdictions since the end of October 2003, therefore comparable data from before this date is unavailable.

The attached table shows, by District Court and nationally, the number of cases on hand that were on hold at the end of September 2007 and were unable to be progressed due to outstanding warrants against all of the defendants on the case. The data is provided by the following four criminal jurisdictions:

- Criminal Summary cases with charges that have been summarily laid
- Youth Court cases with charges laid in the Youth Court jurisdiction (or in the Children's Court which preceded the Youth Court)
- Depositions cases with indictably laid charges (or where there has been an election of trial by jury) that have yet to be committed for trial
- Jury Trial cases where there has been a committal for trial by jury

The following should be noted in relation to the data:

 One case may have more than one accused and, therefore, more than one outstanding warrant.

• It is possible for there to be cases that involve more than one accused to have warrants issued against some, but not all, of the accused. These cases have not been included in the above counts as they generally proceed to trial against any accused still available.

- All cases that are on hold have been included irrespective of whether a date of hearing had been scheduled or not prior to a warrant being issued.
- The execution of outstanding warrants is responsibility of the Police.
