

Building Consents Issued: May 2016



Key facts

In May 2016, building consents were issued for 2,520 new dwellings, comprising:

- 1,956 houses (the highest number since August 2007)
- 327 townhouses, flats, and units
- 121 retirement village units
- 116 apartments.

The seasonally adjusted number of new dwellings consented fell 0.9 percent in May 2016, following a rise of 6.8 percent in April. The seasonally adjusted number has fluctuated in recent months, and the trend is flat.

The actual value of building work consented in May 2016 was \$1.6 billion. For May 2016 compared with May 2015:

- residential work was up \$209 million (24 percent) to \$1,078 million
- non-residential work was up \$5 million (1.1 percent) to \$492 million.


New dwellings down in May

In May 2016, a total of 2,520 new dwellings were consented, comprising:

- 1,956 houses (the highest number since August 2007)
- 327 townhouses, flats, and units
- 121 retirement village units
- 116 apartments.

The seasonally adjusted number of new dwellings fell 0.9 percent, following a 6.8 percent rise in April. The seasonally adjusted number has fluctuated in recent months, and the trend is flat.

For houses only, the seasonally adjusted number fell 4.9 percent, following a 14.9 percent rise in April. The trend increased for the 15th consecutive month.




New dwellings up in 10 of 16 regions

In 10 of the 16 regions, the number of new dwellings consented in May 2016 was higher than in May 2015. The regions with the largest increases were:

- Bay of Plenty up 97 (67 percent) to 242 •
- Auckland up 81 (12 percent) to 732 •
- Canterbury up 69 (13 percent) to 618, including 79 apartments •
- Waikato up 63 (25 percent) to 317 •
- Northland up 53 (87 percent) to 114, including 36 retirement village units.

The national number of new dwellings consented in May 2016 was 349 more than in May 2015 (up 16 percent).


New dwellings consented



The trend for the number of new dwellings consented in Auckland has tailed off since late 2015. The Waikato trend appears to have flattened, and for Wellington has stabilised. The trend for the rest of the North Island is growing.

The trend for Canterbury has edged up, while that for the rest of the South Island appears to be decreasing.



Apartments value up but number steady in May 2016 year

The number of apartments consented in the year to May 2016 was 2,095, little changed from the May 2015 year. However, the value of consents for apartments has grown by two-thirds over the same period. This is partly due to some projects where the building structure has been consented, but the apartments themselves haven't yet been consented. Value is added with each consent for apartment buildings, but the number of apartments is normally counted at the stage with the highest value.



In the year to May 2016, 28,387 new dwellings were consented, up 13 percent from 25,114 in the May 2015 year. This is an 11-year high. Most of the growth was in the Auckland and nearby regions, while Canterbury decreased.


Canterbury earthquake-related consents total \$3.7 billion

Since September 2010, \$3.7 billion of Canterbury's consents have been identified as <u>earthquake-related building consents</u>. This includes consents for 4,473 new dwellings.

Not all earthquake-related consents can be identified. For comparison, total figures for Canterbury from September 2010 to May 2016 were:

- \$17 billion of building consents (all construction)
- 29,469 new dwellings consented.

In May 2016, the value of consents identified as earthquake-related in Canterbury was \$52 million (of a total of \$374 million for Canterbury). This included 78 new dwellings (of a total of 618).

Non-residential building consents valued at \$492 million

The value of consents for non-residential buildings in May 2016 was \$492 million – up \$5 million (1.1 percent) from May 2015. The largest contributors to the latest month's value were:


- education buildings \$115 million
- shops, restaurants, and bars \$100 million
- offices, administration, and public transport buildings \$66 million.

In the year to May 2016, the regions that contributed the highest value of non-residential building consents were:

- Auckland \$1.9 billion
- Canterbury \$1.8 billion
- Wellington \$0.5 billion.




Value of non-residential building consents

Consents for all buildings total \$1.6 billion in May

The total value of building work consented in May 2016 was \$1.6 billion. This comprised \$1,078 million of residential work, and \$492 million of non-residential work.

For the year ended May 2016, compared with the year ended May 2015, the value of buildings consented increased for:

- all buildings up \$2.2 billion (14 percent) to \$17 billion
- residential buildings up \$1.7 billion (18 percent) to \$11 billion
- non-residential buildings up \$457 million (8.5 percent) to \$5.9 billion.
