 - 3. Where a vacancy exists, it remains a vacancy when temporarily filled.

^{***} The majority of the reported Nursing vacancies at Waikato DHB (144.8 FTE) are for Vaccinator roles, which could potentially be filled by other health professionals, as well as nurses.

- Vacancy rates (except for Auckland DHB) are calculated as the vacant FTE divided by the sum of the vacant and contracted FTE (excluding casuals, contractors, people on leave without pay or on parental leave).
- Nursing vacancy data was initially extracted from the HWIP database on 10
 December 2021 and reflects the number of full-time equivalent vacancies reported
 as at 30 September 2021.
- Nursing vacancies are those vacancies coded under ANZSCOs within the HWIP Nursing Occupation Group. This will include Nurse Managers, Nurse Educators, Nurse Researchers, Nurse Practitioners, Nursing Clinical Directors, Registered Nurses and Enrolled Nurses.
- The DHBs were asked to verify the vacancy data and Auckland, Northland, Southern and Taranaki DHBs subsequently provided updated vacancy information.
- Auckland DHB also provided budgeted FTE for the month of September 2021 for use in the calculation of their vacancy rate, rather than using Contracted FTE as at 30 September 2021.
- Northland DHB's vacant FTE are as at 5 December 2021, while vacant FTE data for all other DHBs is as at 30 September 2021.
- Vacancies for Canterbury and West Coast DHBs are advertised vacancies that will
 include roles that are not yet vacant and exclude positions filled but not yet started,
 as well as some vacant roles that the DHBs are not currently recruiting for.
